 - Homeowner with wire fence for deer control:
 - ARB denied Mr. Karim and the HOA cannot look into curbing their deer problem. It was decided that Mr. Karim will lead a committee on nextdoor and share with neighbors some best practices to keep out the deer. The BOA voted unanimously on ARB decision

d. Landscaping

d.ii. Dir. King contacted a tree subject matter expert to inspect a large tree at 15461 Marsh Overlook to see if it needed to be cut down. The subject matter expert suggested that the tree be left alone.
