1.0 Welcome & Administrative Matters

1.1 Bill convened the meeting

2.0 <u>Committee Reports/Recommendations</u>

- 2.1 Meeting Minutes: Minutes for the October HOA meeting were reviewed, and approved by voice vote.
- 2.2 Treasurer's Report:
 - 2.2.1 Financial highlights as of Oct. 31, 2011
 - Oct revenue was \$1.5k; total assessments collected YTD of \$38.2k \$5.6k in arrears.
 - YTD revenue is \$46k \$2.6k over budget.
 - Oct expense was \$2.75k.
 - YTD Expense is \$25k \$14k under budget (primarily due to reductions in landscaping, legal and admin fees).
 - YTD surplus is \$21k.

Total assets are \$164k, comprising the following:

- Cash balance of \$72k.
- CDs totaling \$86k.
- Assessments receivable of \$5.6k.

Total liabilities are \$2.3k leaving remaining net assets of approximately \$161k.

- 2.3 Architectural Review Board
 - 2.3.1 Dan was absent, but did submit ARB items for the semi-annual newsletter

3.0 Old Business

3.1 Bill provided a summary of the email exchanges with Dave Lamb regarding flooding issues on Dave's property on Marsh Overlook. PW County cannot do anything at the top of the hill (road) because it is not county property. Dave is getting dirt hauled in at the top of his property to help divert water flow. Bill plans
